# EHarvest™ PROCESSING SYSTEM

## LRP QUOTING TOOL OVERVIEW

The Hudson Crop LRP Quoter allows for 24-hour access by the user to identify RMA's LRP insurance coverages offered for a particular effective date.

### Accessing the LRP Quoter

Login to the below portals using your eHarvest credentials. If you do not know your credentials, please contact your Regional Sales Manager.

- **eHarvest:** Click on the Livestock tab, then "Create Quick LRP Estimate."
- **myHudson:** Click on the yellow eHarvest button at the top of the page. Once redirected to eHarvest, follow above eHarvest steps.

### Functionality

- Quoter is updated daily when RMA releases the Livestock ADM file, typically between 3:30 and 4:30 PM CST.

### Running a Quote

- **Step 1:** Select the most recent effective date (sales date) available. Then, select the desired state, commodity and type. *(The offerings available for the chosen effective date will display in a table. Table information provided: endorsement length (coverage period), end date (of the coverage), expected end value, coverage price, coverage level and premium rate.)*
- **Step 2:** Enter the number of head, expected end weight (target weight) and ownership share. Then, click the calculate button. *(The insured value, total premium, premium subsidy, and producer premium are calculated based on the number of head, target weight, share and coverage offerings in the table.)*
- **Step 3:** Print or save quote in PDF format if desired.

### Limitations

- Quoter only allows a user to view that last 6-months of offerings. Such view is a rolling 6-month period.
- If the user wants to view LRP offerings older than 6 months, they must visit the RMA website.

### THE BENEFITS

- Quote livestock coverage quickly without having to access RMA's website for LRP offerings
- Producer premium amount provided on a dollar per hundredweight (\$/cwt) and dollar per head (\$/head) basis so user does not have to manually calculate
