ACREAGE CROP REPORTING STREAMLINING INITIATIVE (ACRSI)

ACRSI reduces duplicative crop reporting of acreage information by producers to both the FSA and RMA. It establishes a common framework for agricultural producers to submit acreage reports to the USDA.

Hudson Crop is pleased to offer its agents the ability to pull information from the ACRSI Clearinghouse into our eHarvest® Integrated Mapping System. The integration of ACRSI will:

- Improve the customer experience
- Reduce the customer burden
- Eliminate redundancy in data
- Increase data integrity and data sharing within USDA; and
- Provide process efficiencies

The Process

Currently, producers provide similar acreage reporting information through two different reporting channels: their FSA county office and crop insurance agent. Producers must still contact both parties to validate data and sign acreage reports, but the common data from the first-filed acreage report will now be available to pre-populate and accelerate the completion of the second report, reducing the overall time spent filing acreage reports.

See below the general process that needs to take place before pulling ACRSI into Hudson Crop's Mapping System.

1. Producer chooses a reporting channel to reports their common crop acreage information:

- **FSA Office** - Data automatically transmitted electronically to RMA. RMA will only share data with AIP if a crop insurance policy is in force for the approved ACRSI crops.
- **Crop Agent** - Data is transmitted electronically to FSA.

2. After the producer chooses a reporting channel and such channel submits to the ACRSI Clearinghouse, data is shared electronically and securely among participating USDA agencies.

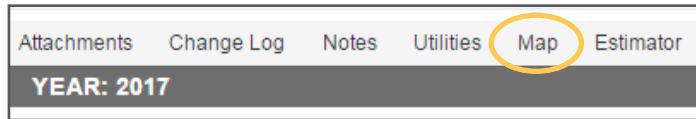
Acreage report data will be shared commonly for those producers who:

- Have planted one or more of the approved crops;
- Carry crop insurance on approved crops; and
- Carry insurance with a participating AIP with a policy in force

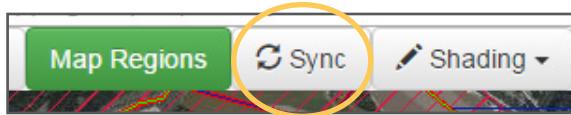
3. Data is ready to pull into Hudson Crop's Integrated Mapping System. (See reverse for the steps.)

HOW TO PULL ACRSI INTO MAPPING

1. Open a policy within the eHarvest Processing System and click on the “Map” tab.



2. Click the “Sync” button.



3. Click the “Sync from ACRSI” tab.

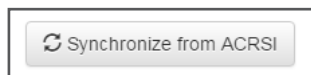
4. Here you can expand, collapse (by clicking the line(s)) and select (using the check boxes) various desired lines to pull in from ACRSI.

NOTE: If no fields show, this indicates ACRSI data has not yet been transmitted for that policy.
